## OPEN STATES Eligibility on All India Basis for State Private Institutes

# Q1. What is an "OPEN STATE" in NEET PG Counseling?

OPEN STATE is an unofficial term used by UG/PG medical aspirants. It refers to a state which allows NEET PG qualified candidates from all over India to register, apply and be eligible for a % of <u>PRIVATE INSTITUTE SEATS</u> in the state. All qualified NEET PG candidates from any other state, including FMGs therefore are eligible therefore for these Private institute seats

#### Q2. What about State Government institute seats? An OPEN STATE – does it refer to State Govt seats too?

No state allows all candidates across India to be eligible for the State Government Institute seats in the state. They have clauses state MBBS, state domicile, residence, nativity or origin, parents' resident state, employment in PSU within state etc... (not exhaustive) as criteria for State Govt Seats.

#### OPEN STATE does not refer to eligibility for State govt seats. It is only with reference to Private Institute seats

### Q3. Which states are the OPEN STATES? How do I apply for an OPEN STATE?

The following are the OPEN STATES which have been verified. The list is not exhaustive and there may be a few other states. Check each state's prospectus and websites and confirm once they are released.

- 1. Andhra Pradesh (separate Management Quota counseling referred to as CAT B seats)
- 2. Bihar

- 6. Madhya Pradesh Choice filling allowed from round 2 (but minimal number of seats usually allotted)
- Pondicherry All candidates across Indian eligible from Round 1 for Sri Manakula Vinayaka. For PIMS (Christian Minority) and SVMC & RI (Telugu Minority) only Pondicherry resident minority candidates eligible in Round 1. After allotment to Minority candidates in Round 2, the balance seats are converted to Management Quota (allotted to All candidates across India in Round 2)

- 11. Tamil Nadu (separate Management Quota counseling)
- 12. Telangana (separate Management Quota counseling referred to as CAT B seats)
- 13. Uttar Pradesh

# Q4. What will be the fee structure of these private institute seats which come under the OPEN STATES (for which all candidates all over India are eligible)?

The fee structure for these seats is usually on the higher side (i.e., higher compared to private seats available for state candidates if there is such a separate categorization). Please check in each state prospectus or notification for details before registering for the state counseling, as the fee structure keeps varying across states and may be different for ALL INDIA BASIS eligible candidates.
