

#### **MESSAGE**

The result of National Eligibility Entrance Test for NEET-MD/MS/PG Diploma 2024 courses was declared on 23<sup>th</sup> August, 2024. The J&K BOPEE is now going to start online Registration of candidates, who have qualified NEET MD/MS/PG Diploma courses for the preparation of Provisional Merit List (PML). After notifying PML, the BOPEE will invite online preference forms for selection of candidates both in MD/MS/PG Diploma courses for the session 2024-25 in various Medical Colleges of the UT of J&K.



The candidates are advised to go through the e-Brochure of NEET-PG 2024, which has been uploaded on the BOPEE official website <a href="www.ikbopee.gov.in">www.ikbopee.gov.in</a> for detailed general and technical instructions along with the rules and procedures for filling up of online registration/preference forms. The candidates should weigh all pros and cons before filling online preference forms. The seats will be allotted on the basis of merit cum preferences given by the candidates, read with reservation rules and relevant Government orders issued by competent authorities of the UT of J&K. There is a provision of debarring the candidates for three/two years/penalty, if any, imposed by Government, who leave the course midway. The candidates, once selected, should, therefore, take a conscious decision before joining a course.

The Board has introduced many technological measures to facilitate candidates from online registration to the online mode of filling up of preference forms, online deposition of fee, SMS facility of status of registration form (as& where applicable)preference forms, video counseling facility simultaneously at Jammu and Srinagar, new candidate friendly website <a href="www.jkbopee.gov.in">www.jkbopee.gov.in</a> with regular update, etc.

The candidates should remain in touch with the BOPEE website regularly for latest update of information and should go through the e-Information Brochure for all the information regarding intake capacity/fee structure, updated seat matrix, reservation policy, schedule (tentative) of counselling, format of category certificates, etc. In case of any query/help, they can write to BOPEE at <a href="mailto:coejakbopee@gmail.com/helpdeskjakbopee@gmail.com/

#### 1. IMPORTANT TERMS AND EXPRESSIONS:

Terms and expressions used hereinafter have specific meanings as given below:

- ❖ Advertisement Notice:- means Notification issued for admission to MD/MS/PG Diploma and courses by National Board of Examinations (NBE) inviting applications from eligible candidates for appearing in Entrance Test;
- ❖ Available Seats: means number of seats intimated by the Medical Colleges and Institutions, Government or Private of the UT as approved by Medical Council of India and, as the case may be;
- ❖ Eligible Candidate: means a candidate, who fulfills requirement of eligibility as prescribed by the BOPEE, Government, Affiliating Universities and or regulating bodies viz. MCI etc. and those notified in the NBE Notification while inviting Online applications;
- ❖ Incomplete Form: means a form which is wrongly filled in or contains false information of any kind or is not having required and /or valid certificates/ photographs or has any other deficiency whatsoever. It shall include online submission of Forms also.
- ❖ Late Receipt: means any document as required to be submitted but not received in office of the BOPEE, Srinagar/Jammu within stipulated time mentioned in notification/notice which includes such documents sent by registered post/speed post within stipulated time but reaching office after expiry of date. It shall include any document uploaded online after expiry of the date.
- ❖ Provisional Merit List: means, Provisional list of candidates, for the UT of Jammu and Kashmir &Ladakh who have appeared in NEETPG/ Entrance Test, drawn in descending order of their inter-se-merit and shall include candidates, if any, whose merit position has undergone a change by additional marks/weight-age as provided under rules;
- ❖ Private Educational Institutions: means Institutions/Colleges established and or administered by registered societies, public trusts or religious and charitable trusts offering professional courses and duly approved/recognized by Government of Jammu and Kashmir and regulating bodies such as MCI, as the case may be;
- ❖ Qualifying Examination: means MBBS or an equivalent Examination for PG.MD/MS in Degree & Diploma Courses and BDS or its equivalent Examination for course;
- \* Rules: means Jammu and Kashmir Board of Professional Entrance Examination Rules-2014;
- ❖ Reservation Rules: means Jammu and Kashmir Reservation Rules notified vide SO 176 of 2024 dated 15-03-2024, SO 305 of 2024 dated 21-05-2024 as amended from time to time including amendments carried vide SRO 49 of 2019, S.O. 249 of 2021;
- ❖ NEET Qualifying Marks/Score: means such qualifying marks/score as notified by NBE or by MCI for NEET MD/MS/PG Diploma 2024 Courses respectively from time to time;

- ❖ Courses: means /MD/MS/PG Diploma Courses for which admission is to be made;
- ❖ Registration Form: means online registration form filled by the candidate for preparation of Provisional Merit List;
- ❖ Online Preference Form: means an online application to be filled in by the eligible candidates to indicate their preference for seat (discipline/college).

#### 2. INTRODUCTION AND CLARIFICATION:

Consequent upon the issuance of an Ordinance namely Indian Medical Council (Amendment) Ordinance issued on 24<sup>th</sup> May, 2016 to carry out the amendment in MCI Act, following Section 10D was, inter alia, inserted in the said Act:-

"10.D. There shall be conducted a Uniform Entrance Examination to All Medical Educational Institutions at under graduate level and post-graduate level through such designated authority in Hindi, English and such other languages and in such manner as may be prescribed by designated authority shall to ensure conduct of Uniform Entrance Examination in aforesaid manner;

Provided that notwithstanding any judgment or order of any Court, provisions of this section shall not apply in relation to Uniform Entrance Examination at undergraduate level for academic year 2016-17 conducted in accordance with any regulations made under this Act in respect of State Government seats (wherein Government Medical College or in a Private Medical College) where such State/UT has not opted for such examination"

The first Common Entrance Examination at the national level for admission to MD/MS/PG Diploma and Courses was held by the National Board of Examinations w.e.f. 5<sup>th</sup> December to 13<sup>th</sup>December, 2016. The examination is being conducted regularly by National Board of Examinations on annual basis. The examination for 2024 was held on 11<sup>th</sup> March, 2024 in respect of MD/MS/PGD Courses. The post examination processes, including the counselling and allotment of seats have to be carried out by the State/UT Counselling Authorities and in respect of J&K & Ladakh by the J&K Board of Professional Entrance Examinations.

Further, in pursuance of amendments carried out in the Post Graduate Medical Regulations, 2000 (Regulation 9A(4) vide Medical Council of India Notification No. MCI-18(1)/2016-Med./176290 dated 10<sup>th</sup> March, 2017:-

"The counselling for all post graduate courses (Diploma/MD/MS/DM/M.CH) in all Medical Educational Institutions in a State/Union Territory, including Medical Educational Institutions established by the Central Government, State Government University, Deemed University, Trust, Society or a Company/Minority Institutions/Corporations shall be conducted by the State/UT Government. Such Common Counselling shall be under the over-all superintendence, direction and control of the State Government."

For the academic year 2024, the National Board of Examinations invited applications from the eligible candidates and the examination for was conducted on 11<sup>th</sup> August, 2024 for MD/MS/PG Diploma at different centers. After declaration of the result for NEET 2024 by the National Board of Examinations on 23<sup>rd</sup> August, 2024 in respect of MD/MS/PG Diploma Courses, the Merit List is to be notified by the Competent Authorities of the UT Governments (J&K BOPEE in respect of UT of Jammu and Kashmiri), after updating the bio-data of the candidates including their category status. The counseling of the candidates, finally found to be eligible for admissions, is also to be conducted by the BOPEE. The process can begin only after data from NBE is received by the BOPEE. As per the result declared by the NBE vide their Notice dated 10-03-2024the cut off score for NEET is as under:-

#### 3. ABOUT J&K BOPEE:

The Jammu and Kashmir Board of Professional Entrance Examinations Act was enacted in 2002 and rules have been issued vide SRO 168 of 2014. As per the Act and rules thereunder, Board is the Competent Authority to make selections of candidates for admissions in professional colleges, hold counseling and take such other steps as may be considered necessary for making selection of candidates to professional courses in professional institutions of the UT of J&K. However, in view of the directions of the Hon'ble Supreme Court to conduct a common entrance test at the All India level and amendments carried out in MCI Act, the Board undertakes all other activities related to the admissions except conduct of examination. NBE has no role whatsoever, except for conducting a common entrance test for admission to PG courses on provisional basis. The determination of the eligibility, verification of the documents, preparation of the Provisional Merit List, counselling and the allotment of seats is being done by the BOPEE on the basis of the rules and procedures as notified in this information brochure.

#### 4. CLARIFICATIONS ABOUT NEET:

NEET-PG is an eligibility-cum-ranking examination prescribed separately as entrance examinations to various MD/MS and PG Diploma and MDS Courses respectively as per section (10) of Indian Medical Council Act, 1956;Dentist Act 1948 (amended from time to time).

NEET-PG is a single window Entrance Examination for Medical PG courses. No other Entrance Examination, either at state/UT or institute level, in the UT of Jammu and Kashmir shall be valid for entry to MD/MS/PG Diploma and Courses as per Indian Medical Council Act, 1956/Dentist Act, 1948w.e.f. 2017 admission session as applicable to 2024 as well.

#### **5. SCOPE OF NEET-PG / 2024:**

50 % seats for MD/MS/PG Diploma and Courses in the UT of Jammu and Kashmir shall be filled through the NEET examination only& rest 50 % seats shall be filled through MCC by AIQ. BOPEE shall fill all seats in private Medical College including those under the Management/NRI Quota;

The allocation of seats for MD/MS/PG Diploma Courses for academic year 2024-25 in various medical Institutions/medical colleges under the ambit of PG Course Regulations shall be undertaken as per procedure prescribed in Postgraduate Medical Education Regulations published by MCI read with reservation policy and or orders of Union Territory Government as applicable from time to time to such selections and contained in the e-brochure;

For admission to medical post graduate courses and at Government/Private colleges in the UT of Jammu and Kashmir, a Provisional Merit List (PML) of eligible candidates shall be drawn on the basis of the NEET PG/ - 2024separately for PG & Courses result and registration of the candidates with the BOPEE. These PML(s) will be used by the BOPEE for selection and admission to medical postgraduate courses at Government/Private Medical for which examinations were held through the NEET-PG 2024. These lists shall be applicable only to the seats at the disposal of the Competent Authority viz the J&K BOPEE, for Government/Private Colleges admissions for the year 2024-2024. The necessary rules, guidelines etc. are annexed with this Brochure.

#### 6. COMPETENT AUTHORITY:

BOPEE, being the competent authority to make admissions to medical colleges/institutions in UT for MD/MS/PG Diploma courses, various instructions through notices will be issued by Board to keep candidates up-dated with regard to various developments, changes taking place after declaration of NEET result. A step by step procedure will be followed. The final time table will also be notified by Board for filling up seats in accordance with UT rules/MCI regulations and other rules, if any, on the subject.

#### 7. DESIGNATED AUTHORITY:

Board has taken up with concerned medical colleges/institutions to designate a team of officers to facilitate selected candidates at the time of admissions in colleges/institutions who have been asked to nominate senior faculty members also for the purpose to supervise such admissions and provide necessary guidance to the candidates. The designated authority of the Colleges/Institutions shall interact with the BOPEE, and monitor submission of requisite information to the BOPEE, as may be required.

#### 8. GRIEVANCE REDRESSAL MECHANISM:

BOPEE has already established an interaction system with the candidates through which queries of candidates are being addressed. Candidates are advised to address any query to Secretary/ COE, BOPEE with full details enabling the Board to examine such queries and take further action as may be required in accordance with the law. However, the Board will not respond to any such query, which has been discussed in the Brochure. The queries raised by the candidates are responded through "FAQ" available on the BOPEE website www.jkbopee.gov.in/www.jakbopee.org.

#### 9. DURATION:

- ✓ Duration of Postgraduate Medical shall be three years or as notified by MCI.
- ✓ Duration of Postgraduate Medical Diploma Course shall be two years or as notified by MCI.

#### **10.ELIGIBILITY OF CANDIDATES:**

- a. The candidate must be a resident of UT of J&K or Ladakh as the case may be
- b. The candidates who were nominated by the Government of India (under Central Pool Seats) to do MBBS from Medical Colleges in Jammu and Kashmir shall be eligible for All India 50% Quota seats. Such candidates must have to submit a duly signed undertaking to the prescribed authority declaring that he/she was nominated by the Government of India (Central Pool Seats) to do MBBS from Medical College in Jammu and Kashmir.
- c. The candidate must possess MBBS (as the case may be) degree from the University of Jammu/University of Kashmir or an equivalent degree recognized by University of Jammu/University of Kashmir and Medical Council of India and also registered with Medical (as the case may be). The MCI/SMC registration is mandatory for NEET-PG 2024 qualifying candidates. Registration Certificate should be produced as per notice or as may be notified by the NBE:
- d. the candidate must have completed, by or before 15-08- 2024, satisfactorily one year preregistration compulsory rotator internship in a duly recognized institution as laid down by the University of Jammu/University of Kashmir for registration as a Medical graduate. As cut-off date of having completed internship has already been mentioned by NBE while inviting applications for online test, BOPEE is, therefore, not competent to alter this date and take it beyond 15-08- 2024;
- e. the candidate must be eligible (wherever applicable) in terms of SRO-48 of 2018(Annexure 'B'):
- f. the candidate must fulfill such conditions as laid down in NBE Information Brochure, 2024, if the candidate has passed MBBS from outside the country;

#### Note:

Only such candidates shall be considered for admission for MD/MS/PG Diploma Courses who have qualified NEET PG 2024, held by National Board of Examinations and figure in the Provisional Merit List;

- g) For being eligible to be called for counselling for Online/offline submission of Preference, as may be decided by the Board, candidates belonging to:-
- 1) "OM" category must have scored minimum marks at 50th percentile as mentioned above;
- 2) Reserved categories viz SC/ST-i/ST-ii and Socially and Educationally backward classes (RBA/ALC/IB /OBC) must have scored a minimum of 40th percentile as mentioned above;
- 3) Categories, CDP, JKPM, EWS and SP shall be considered only if they have scored minimum of 50th percentile marks/qualifying score as laid down by the NBE;
- 4) Subject to the conditions of eligibility as laid down in MCI-PG regulations candidates who have served in difficult areas shall be awarded weight-age on the basis of marks as may be awarded to them in accordance with the SRO 48 of 2018 only if they have served in areas notified as per SRO 201 of 2006 (Annexure "A").

#### Note:

i. The qualifying percentile should match with the cut off score, as determined by the NBE;

- ii. The above eligibility is bare minimum and only such eligible number of candidates, as may be deemed fit by the BOPEE, shall be called for Online/offline submission of Preference Forms. The candidates who fall in the qualifying zone but fail to register themselves with the BOPEE/upload online documents/deposit their documents within the stipulated date, notwithstanding, their score in NEET shall in no case be allowed to participate in the counselling/considered for allotment of a seat,
- iii. Conditions specified in Information Bulletins/Brochures issued by NBE regarding short listing etc. but not mentioned in this Brochure shall apply.

#### h) Further;

- 1. "Socially and Educationally Backward Classes" is a reservation category comprising RBA/ALC/IB /OBC. Since in NEET, online application form, there was no column meant for such categories, therefore, such candidates must have applied in "Open Merit" category or OBC. Since the UT category has not been provided, the UT category certificates have to be collected from the eligible candidates of the UTs of J&K/ Ladakh as per existing reservation policy& modified, if any, and guidelines applicable in the UT of J&K. Accordingly, the candidates shall have to upload online all certificates including reservation category certificates upto the dates as may be notified by the Board. In case the validity period of certificate of any candidate belonging to the reserved category has expired, the same should have been got renewed before the last date of filling up of the online registration forms.
- 2. Since the candidates have to submit the category certificates and other documents only after the declaration of the NEET PG result and during online registration, the cut-off date of determination of eligibility of validity of category certificates for all purposes shall be the last date for registration of candidates and submission of documents as may be fixed by the Board (after the declaration of the NEET-PG result). No under process certificate shall be entertained.
- i) Such candidates, who have done their Post-Graduation or Diploma Courses in any specialty at Government expenses shall be entitled to seek admission for undergoing further Post Graduation or Diploma in another specialty in Medical Institutions of UT of J&K on payment of such fee as may be notified by Government from time to time. Such candidates shall be eligible in terms of SRO 08 of 2005 read with SRO 48 of 2018;
- j) Further, as per SRO 08 of 2005 read with SRO 48 of 2018 such Doctors who are doing Post Graduation/Diploma Courses in any specialty at Government expenses shall not be eligible to apply for undergoing Post Graduation Courses in any other specialty in Medical Institutions of UT of J&K till completion of their Post-Graduation/Diploma Courses, as the case may be. Such candidates who have been granted admission in previous years but have left the course midway after taking the admission shall not be eligible to participate in the counselling process;
- k) "In-service candidates" who have qualified NEET-PG 2024 and fall in the zone of consideration will be considered subject to issuance of 'NOC' by prescribed competent authority. Board may have NOC certificates issued by the competent authority verified

from such authorities if it is found expedient to do so. However, they will be allowed to participate in the registration/counselling provisionally but will be allowed to join the college on production of NOC only within the stipulated date in terms of.

**NOTE:** -In-service certificate of the doctors must be forwarded by the, **Director Health Services**, Jammu/ Kashmir, as the case may be, and shall be uploaded online/submitted in the BOPEE office Jammu/Srinagar within prescribed last date. Board reserves its right to have such certificates verified by the Government.

#### 11.NON-ELIGIBILITY OF CANDIDATES:

- 1) Following candidates are not eligible for filling up of Preference form at NEET-PG/ 2024:
  - a) candidates who have not appeared for NEET-PG/ 2024 conducted by National Board of Examination, New Delhi;
  - b) the candidates who have appeared in the NEET Examination, 2024 but have failed to secure the minimum qualifying percentile score as prescribed by the National Board of Examinations as mentioned in preceding paras;
  - b) Candidates who have not completing internship on or before 15-08- 2024;
  - c) The candidates who fail to produce original documents in the Board office (in case of offline mode), and/or fail to upload scanned copies of original documents online within the time frame as may be determined by the Board;
  - d) candidates who have not applied / not obtained J&KMC/MCI registration as the case may be;
  - e) Candidates, who are registered for PG/diploma and have not passed course(SRO 08 of 18<sup>th</sup> January, 2005 read with SRO 48 of 2018);
- 2) There shall be no admission of students in respect of any academic session beyond the last date fixed by MCI from time to time or any other date notified by the competent authority for postgraduate courses under any circumstances. The Universities shall not register any student admitted beyond said date;
- 3) Medical Council of India may direct that any student identified as having obtained admission after last date for closure of admission be discharged from course of study, or any medical qualification granted to such a student shall not be a recognized qualification for the purpose of Indian Medical Council Act. The institution which grants admission to any student after last date specified for same shall also be liable to face such action as may be prescribed by MCI including surrender of seats equivalent to the extent of such admission made from its sanctioned intake capacity for succeeding academic year.

#### **12.DIFFICULT AREA SERVICE:**

- ➤ In terms of SRO 48 of 2018 dated 30-01-2018, the candidates shall be entitled to weightage for serving in the difficult areas as defined under notification SRO 201 of 2006 dated 15-06-2006 to the extent of additional 10% for each year of completed service in such areas subject to a maximum of 30% of the marks obtained in the written test.
- ➤ Provided that each completed year of service shall mean actual service days even on adhoc/contractual basis or as NRHM Doctor in these areas to be certified by the concerned Director Health Services and shall exclude the days spent on any training programme or absence of any kind except such absence on casual leave.

**Note:**(1) Subject to the provisions of SRO 08 of 2005 read with SRO 48 dated 30-01-2018, a candidate, who is pursuing any PG or PG Diploma Course in any specialty at the Government

expenses, is not eligible to appear in MD/MS/ PG Diploma Entrance Test unless he/she has completed that course. However, a candidate, who has appeared in final/end term Entrance Test of PG or PG Diploma Course on the last date of submission of Online NEET Application Form, 2024 but his/ her result is yet awaited and will be declared before last date of online registration, is eligible to appear in the process. He/she shall have to inform the BOPEE with full details about the matter and any concealment of facts shall make his/her candidature liable for action including cancellation of his/her admission, if selected.

- (2) "provided further that the doctors who are doing post-graduation/diploma courses in any specialty at the government expenses including those who leave the course midway after cut-off date of admission shall not be eligible to apply for undergoing post-graduation courses in any other specialty in the J&K Medical Institutions till completion of their post-graduation/diploma courses, as the case may be. In case of candidates having left the course midway after taking admission they shall be barred from seeking admission again complete the course that they had left midway,
- (3) The candidates who were previously admitted to the MD/MS/PG Diploma and courses but have left the same midway shall not be eligible for consideration/counseling atleast for 03/02 years for admission to MD/MS/PG Diploma/ respectively.

- I. \* candidate having a certificate that his/her father is working in <u>Defence Establishment</u> (Military Engineering Service ,paramilitary force or other service of like nature) where salary is paid out from <u>Defense Estimates</u> is not entitled to benefit of CDP Category. <u>Admission of such a candidate on the basis of a certificate which is wrongly accepted will be cancelled as and when such a mistake/ fraud comes to the notice of Board.</u>
- II. \*\* candidates having "Outstanding Proficiency in Sports" must submit their certificates to Secretary, J& K Sports Council for awarding points which will be then officially submitted to the Board by the Sports Council. Board shall not be responsible where a candidate fails to submit certificates to the Council or Council fails to forward points of a candidate to Board. It shall be sole responsibility of candidate to ensure that his/her sports points are forwarded by Council to Board. The admission under the Sports Category shall be strictly on the basis of NEET merit (score) of the candidates and the preference indicated by them. Sports merit provided by the Sports Council of J&K shall be considered only for determining the eligibility/short listing of such candidates under the Sports category.
- III. It shall be necessary for a candidate to obtain at least minimum qualifying marks/score in Entrance Test for Courses as prescribed for different categories under Jammu and Kashmir Reservation Rules and MCI Regulations, as amended from time to time. For the selection of candidates who appeared in NEET 2024, the cut off scores notified by the NEET as qualifying points shall be relevant. Since the CDP,JKPM, SP, categories are not recognized by MCI, minimum qualifying marks for such candidates shall be as required for OM Category of candidates and shall be regulated in accordance with law/rules on subject. ### 14.DISTRIBUTION OF MD/MS/PG DIPLOMA SEATS:

#### Distribution of PG Medical Seats from Government/Private Medical Colleges:-

The seats available for admission to medical courses through NEET-PG 2024 will be from Institutions located in UT of J&K i.e. Government/Private medical colleges. The UT of J&K is also contributing to All India quota; therefore, all seats of J&K quota available in Government medical colleges shall be filled through the NEET 2024. All seats in private college shall also be filled by the BOPEE. Tentative intake available in UT of Jammu & Kashmir given e- Brochure shall be notified separately. Seats available will be filled on the basis of UT Merit List in NEET PG 2024 with due regard to the preferences submitted by the candidates, Reservation rules and other orders of UT, MCI regulations.

Selection of candidates from Reserved Categories for different streams in MD/MS/PG Diploma courses shall be made strictly on the basis of their inter-se merit treating them as a single class for the purposes of allotment of Streams in terms of Rule 15 of J&K ReservationRules,2005 as amended vide SRO 49 of 2018 dated 30-01-2018. In addition, in course, selection of candidates for reserved categories will be done as per roster issued vide SO 305 of 2024. However, since there is no reservation for in-service candidates serving in rural areas, the roster point, if any, allocable to rural service under SRO 154 shall be allocable to the OM candidates.

#### 15.RULE 17 OF RESERVATION RULES, 2005 read with SRO 49 of 2018:

**"17.** Allotment of Disciplines etc.: - A reserved category candidate, if selected against the open merit seat may be considered for allotment of discipline/stream/college allocable to him/her in his/her respective category on the basis on his/her merit and preference. The left over disciplines/stream/college in the open merit category shall be allotted to the reserved category candidates who get selected consequent upon the reserved category candidates getting selected in the open merit category.

#### **Explanation:-**

The left over discipline shall mean such number of disciplines/stream/college becoming available after allotment of seat to the last open merit candidate as allocable under rules. Such seats shall be added to the pool of reserved category candidates in terms of Rule-15 and allotted on the basis of merit cum preference."

Postgraduate seats left unfilled in an academic year, shall not be carried forward to the next or subsequent academic year. Last date of joining MD/MS/PG Diploma Courses is to be fixed by MCI as per the guidelines of MCI/New Delhi issued pursuant to the orders of the Hon'ble Supreme Court of India in W.P.(c) 76/2005 and W.P.314/328 of 2015 dated 18/01/2016 Ashish Ranjan and other V/s Union of India. Academic year will start from as per MCI guidelines.(Last date of admissions and

date of commencement of academic year is subject to change as per directions of the Hon'ble Supreme Court or MCI.)

#### **20.DECLARATION OF PROVISIONAL MERIT LIST:**

After registration and verification of the documents of the candidates, who have qualified the NEET examination, 2024, and updation of their records, BOPEE shall prepare a Provisional Merit List (PML) indicating category status of candidates also. The PML shall be in the descending order of merit and shall be inclusive of marks for which a candidate may be eligible as in respect of difficult area/remote service rendered by the candidate as per SRO 48 of 2018 dated 30-01-2018 and in accordance with the MCI regulations. Only such candidates shall be eligible for award of Difficult Area Marks (DAM), who have secured the qualifying marks as fixed by the NBE.

Note: In case, if the merit of two or more candidates is equal in the PML, the interse merit/rank of the candidates shall be determined on the basis of the rank assigned to such candidates by the NBE at the time of declaration of the result.

#### 21. ONLINE FILLING UP OF PREFERENCE FORMS / ONLINE COUNSELLING:

For allocation/allotment of the seats in the Colleges/Institutions, Board has devised an Online submission of Preference Form. Candidates will be required to submit online Preference Form/biodata as may be called by BOPEE in this regard. The online registration/submission of the online Preference Form/online counselling has been introduced to avoid physical presence of the candidates in the office and to make the process hassle free. However, the Board may resort for offline registration, if the number of candidates are not sufficient or as the Board desires to be in any other case.

#### 22.PROCEDURE TO BE FOLLOWED DURING COUNSELLING:-

A tentative schedule for filling up of the online preference forms has already been indicated in the Information Brochure but the final schedule shall be notified in this regard for information of the candidates. Subject to the limits fixed by the BOPEE only such candidates shall be allowed to participate in the counselling process through either online or offline mode who have registered themselves and submitted the documents as required above.

#### 23.FEE TO BE DEPOSITED:

Candidates desirous of filling up of Preference Form for allotment of seats/colleges shall have to deposit an online fee of Rs. 2000/-.Banking transaction charges will be borne by the applicant. Amount so deposited is not refundable. A candidate who has failed to make the online payment as the fee shall under no circumstances be considered for allotment of a seat at all.

**Note**:-The online/offline Preference Form can be submitted/filled inas per the schedule to be notified by the Board. Date in this regard shall be notified separately but in any case the process shall begin only after declaration of the provisional merit list. Candidates are not required to come and to make frequent visits to Board office, as Board encourages online response to queries made by candidates.

- 2. BOPEE is seeking Preferences from such candidates who as have qualified for NEET PG (MD/MS/PG Diploma), 2024 and have been asked to fill in the Preference Form online only;
- **3.** The online/offline Preference Form enables a candidate to fill in the preferences for various disciplines/institutions for allotment of a seat for admission in NEET PG (MD/MS/PG Diploma), 2024 in Medical Institutions/ Private College of UT of J&K as the case may be;
- **4.** Candidates must have obtained password/user ID initially at the time of registration for preparation of PML. The same password/user ID shall be required for login;
- 5. During the online filling up of Preference Form, the candidates will get all the details of the disciplines available viz-a-viz the institutions;
- **6.** In case decided by the Board, Candidates are permitted to conduct dummy exercise (rehearsal) of filling up of the preferences and this shall be available till such time as may be notified by the Board. The objective of this is to give the candidate a clear idea with regard to his preferences;
- 7. While conducting dummy exercise, a candidate should also keep the merit list issued by BOEE, which must have been declared by then, in mind so as to have a fair idea of the merit obtained by him/her vis-à-vis other candidates;
- **8.** This will facilitate candidates to fill up the final Preference Form in a hassle free and relaxed manner;
- **9.** Candidate should select his/her most preferred preference first along with the College of preference followed by second, third, fourth and so on for the said course;
- **10.** The second preference for the discipline shall be given by the candidate by choosing the college preference as above;
- 11. This preference shall be available till all the preferences/ colleges are exhausted by the candidate;
- 12. Candidate will be required to fill up at least one preference for a discipline/college and without entering any preference the candidate will not be able to proceed further;

- 13. Candidates can modify the preferences selected by them till such time they do not finally submit/lock the Preference Form, after which the candidate will not be able to modify the same;
- **14.** The candidate shall have to deposit a **Fee** of Rs. 2000/- online and after submission of online fee the preference form of the candidate will be locked.
- 15. Candidates will get sufficient time to fill in the Preference Form and should not be in a hurry while filling up the Form. This system has been evolved to facilitate candidates to fill in the form online without approaching the BOPEE office in person.
- 16. Candidates who have submitted the form online shall, however, be required to download/print at least one copy of the Preference Form, for its retention by the candidate and must ensure that in the printed form, details of online fee transaction must be reflected in it;
- 17. Candidates should remain in touch with the BOPEE website for update, if any, in this regard;

#### **TECHNICAL**

Only those candidates shall be able to login who have earlier registered online & have been called for counselling.

- 1. Click on "Login" link.
- 2. Enter username: Roll No.
- 3. Enter Password: Same as set during account activation.

After login, candidate can view their *Personal Details* and *NEET Score* by clicking on "Personal Profile".

#### **Submitting Preferences:**

Candidate must lock the preferences before the *last date*; candidates will not be able to lock their choices after the *last date*.

- i) Click on "Subject" link after logging in.
- ii) Select disciplines candidate wants to apply and then click on "Select" button.
- iii) Selected disciplines available in the college will be shown in the "disciplines available box"
- iv) Candidates are advised to select disciplines as per their preferences from "disciplines available box" and clicking on ">>" button to set their preferences, disciplines chosen will be shown in the "disciplines assigned box" with preference selected. If a candidate wants to remove the preference he/she can do so by selecting the preference from "disciplines assigned box" and clicking on "<<" button.
- v) Preferences select by the candidate will be saved *automatically*; candidate will get the operations performed by him/her whenever he/she logs in to the Application.
- vi) Candidate can also see the preview of the preferences selected by him/her by clicking on "**Preview**" button and can also take the print out of the same for their perusal.
- vii) Candidate can **add** and **delete** preferences anytime but before *lastdate* and before *locking* their preferences.
- viii) If candidate wants to lock his/her choices, click on "**Submit**" button; a preview of choices will be shown and if he/she is satisfied with his/her preferences locked him/her then by clicking on "**Submit**" button the *Preview Pageof selected* choices will be *locked*. Once a candidate locks his choices then no modification can be done in the preferences selected.
- ix) Candidates will be given the option to "make payment" of fee online only after the choices are locked, Fee must be paid before the last date of fee submission. Candidates can submit fee after locking their choices and clicking on *subject tab*.

- x) Only those Applications will be accepted having choices locked and have fee submitted on time, Applications failing this criteriashall be rejected.
- xi) Candidates are advised to take **printout** of the preferences they have selected by clicking on "**Print Application Form**" after locking their choices for its retention by the candidate.

#### **Making Fee Payment:**

- i. Fee will only be paid online before the last date of fee submission.
- ii. Fee payment option will be given only after candidate locks his/her preferences.
- iii. Click on "make payment" button, candidate will be redirected to Bill Desk Payment Gateway and make payment by choosing any available option.
- iv. Payment Receipt will be generated after payment is successful.
- v. Candidate can take **print** out of the payment receipt.

#### **25.SELECTION PROCESS:**

Notwithstanding number of candidates who have actually qualified the examination, Board may restrict number of candidates to fill in Preference Forms to at least 2.5 times number of seats available. However, a final decision in this regard shall be taken after the Provisional Merit List notified by the board is notified and candidates would be informed also. This shall also enable Board to fill up seats as may remain vacant due to various reasons including non-joining, resignation etc by candidates. Intention is to ensure that all seats available in the colleges are filled up and no seat remains vacant on completion of the selection process.

Subject to any other conditions contained hereinabove, the selection to a course/college of a candidate will be made considering his/her position in Merit List, the preferences given by candidate and by adhering to the reservation rules.

After completion of the first round of counselling (filling up the preference form) and completion of the allotment process by the Board, a Notification indicating the allotment of seats to the candidates will be displayed on website of BOPEE i.e. <a href="www.jkbopee.gov.in">www.jkbopee.gov.in</a> and shall be published in the leading English dailies also.

All candidates to whom a seat has been allotted in the 1<sup>st</sup> round on the basis of Merit-cum-Preference will have to compulsorily join college and course so allotted, within prescribed period by completing requisite formalities. i.e. submission of original documents as per list given in check-list and by submission of such other documents/undertakings as may further be required by the concerned college/institute.

#### **CLARIFICATION:-**

A candidate, to whom a seat has been allotted in 1<sup>st</sup>round, whostakes a claim for betterment of his/her choice, must initially accept allotment and join College by completing necessary formalities as set out by Rules, failing which such a candidate(s) will not be eligible to participate in second round of counselling, but may be allowed subsequently to compete against such category seats which may remain vacant and the Board may decide

#### to fill the same from OM category candidates.

Seat so allotted to such a candidate who does not join, will be presumed to be a vacant seat as on and immediately after the date set out as last date for joining college in terms of such allotment. Such a vacant seat will be allotted in next round of admission process within prescribed period.

Any upgradation or revision in the allotment of seats/colleges as may become necessary due to resultant seats caused due to non-joining/resignation etc. of a seat etc. will be considered, on the basis of merit-cum-preference only on day to day basis only.

### 26.UPGRADATION/ALLOTMENT ROUND(2ND ROUND OF COUNSELLING)

The following procedure shall be followed in case it is decided by the Board to conduct upgradation/allotment (second round) through **online** counselling:-

- (i) The candidates, who have been allotted a seat during first round and have joined the College/Institution, will be eligible to participate in the upgradation round of counselling;
- (ii) The candidates who participated in the first round of counselling but could not get a seat due to (SNA)/or CNA shall be eligible to participate in the counselling;
- (iii) The candidates eligible/desirous to participate in the upgradation/allotment round shall be required to indicate the fresh preferences for the seats proposed to be filled up (to be notified) during the said round of counselling caused due to non-joining of the candidates/resignation etc;
- (iv) The preferences indicated by the candidates earlier during the first round of counselling shall, therefore, be deemed to be cancelled and shall not be applicable for this round of upgradation/allotment;
- (v) The seats vacated by the candidates during the upgradation process shall automatically be added to the seats available and allotted simultaneously on the basis of merit-cum-preference, purely on day to day basis to the students whose counseling shall be held on that day(s)/dates(s)and not to those candidates who have already counseled on early day(s)/dates(s);
- (vi) The seat allotted to a candidate in the first round, who is participating in the upgradation round shall be deemed to have been surrendered by him/her, and shall be added to the seat matrix to be filled up during second round only if he/she is upgraded and allotted a seat on the basis of upgradation. In absence of his/her upgradation, the candidate shall retain the seat allotted to him/her during the 1<sup>st</sup> round of counselling;

- (vii) The seats left out by the OM candidate during the first round shall be allotted to the OM candidate and those left by the category candidates shall be allotted to the category candidates only during this round of counselling, provided that the seat left by the category candidate belonging to a particular category shall be allotted to the candidate belonging to that category only from which it has become available. For example if a seat in SC category is available, it will be allotted to an SC candidate only;
- (viii) The seats additionally allowed to be filled by the MCI/Government of India, after the completion of first round of counselling and before the filling up of fresh preferences for second round of counseling shall be added to the seat matrix and filled up along with the other seats being filled up during such round.
- Note: -Rule 17 shall not apply during the upgradation/allotment round. The candidates upgraded/allotted a seat shall be required to join the college within the stipulated time as may be notified by the Board.
- Note:-(i) The candidates who join the college on the basis of first round of counselling and wish to participate in the second round of counselling should, therefore, take a very conscious decision for participation in the second round, as unnecessary participation in the process only causes delay in completion of the process.
  - (ii)Board may, if it is expedient to do so, display or notify the list of candidates participating in the second round of counselling along-with the seats allotted during 1<sup>st</sup>round of counselling.

Following procedure shall be followed in case it is decided by the Board to conduct upgradation/allotment round (2<sup>nd</sup> round of counselling) through physical counselling:-

- i. The seats available due to non-joining, resignation etc. shall be notified by the BOPEE. All candidates who have joined the course/college and those to whom a seat could not be allotted during the first round of counselling due to SNA/CNA shall be eligible to participate in the process of counselling/upgradation and those who have not joined on allotment of the seat during the first round shall not be eligible;
- ii. The candidates eligible and desirous of participating in the physical round of upgradation/allotment shall be required to fill in fresh preference forms and the preference forms filled online during first round shall be deemed to be cancelled;
- iii. The candidates shall have to appear during the upgradation/physical round in person before the counselling committee/Board as per the schedule notified by it. The candidates shall have to register themselves in the

Board office in the morning and shall have to participate in the counselling process on their turn. The seat shall be allotted to the candidates who participate in the counselling at relevant point of time on the basis of merit-cum-preference. In case any candidate fails to appear in the counselling at his/her turn he/she shall loose claim on the seat available, which shall be allotted to the next available candidate in order of merit. However, such a candidate who misses the counselling on his/her turn and reports at a later date/time than of his/her turn during the counselling period as notified, shall be considered only against the seat(s), which are available at that point of time; and

iv. The seats vacated by the candidates due to upgradation etc. shall be added to the seat matrix and allotted during the day on minute to minute basis and the seat matrix shall undergo change on minute to minute basis, which shall be displayed on the monitors available in the BOPEE offices. These seats shall be allotted on day to day basis to those candidates whose counseling shall be on that day(s)/dates(s) and not be allotted to those candidates whose counseling have been already completed on previous day(s)/dates(s) irrespective of his/her higher merit.

Note: (i) The physical round of counselling may either be conducted on a single day or on different dates/days as may be notified by the Board. Such seats remaining unfilled at the conclusion of first day of counselling may be carried to the next day/date of counselling as may be decided by the Board. However, the candidates who did not participate in the counselling particular date/day process on notwithstanding his/her higher merit shall subject to the above conditions be eligible to compete for the seats as are carried forward to the next day/date of counselling. Such candidates shall have no claim on a seat which was allotted to a candidate during the previous day/date of counselling on the basis of his/her merit, preference and availability of seat at the time of counselling. In other words the candidates cannot stake a claim on a seat which has been allotted to another candidate on the grounds that the candidate could not participate in the physical round of counselling earlier on time when the seat was available. Such a process, if allowed would mean re-opening of admission/allotment process and thereby result in noncompletion of admissions within the stipulated/prescribed time limit by the MCI/Hon'ble Supreme Court of India;

(ii) The candidates participating in the physical round of counselling and allotted a seat, should in their own interest not to leave the Board office on their day of counselling as there is a possibility that a seat of his/her choice, which was not available on his/her turn of counselling, may become available in the process. He/she can stake a claim on such a seat immediately once the seat is displayed on the monitor of the Board, consequent upon its vacation by a candidate so that such a candidate is considered for allotment of the seat on merit cum preference basis on same day. The seat allotted to him/her earlier shall become vacant and added to the seat matrix, if upgraded. Board shall not be responsible in case a candidate leaves the Board office and he/she fails to stake a claim on a seat as may become available as above.

#### **27.SUBSEQUENT ROUND OF COUNSELLING:**

The Board may, if required, to conduct subsequent round of online counseling/physical round of counseling in the same manner as prescribed for 2<sup>nd</sup> round of counseling provided that:-

The candidates, who did not join the college on allotment of a seat after first round of counseling or on upgradation of seat and or allotment of seat during second round shall not be eligible to participate in the subsequent round of counseling. Those candidates, who have been upgraded during the second round shall not be eligible to participate in this round, notwithstanding his/her joining the College.

#### 28.NRI/HINDU MINORITY QUOTA:

The seats under HMQ and the NRI in the ASCOMS shall also be filled up through a process of joint physical counseling after the above process is completed. Only such candidates shall be allowed to participate in the counseling for such seats, who fulfill the eligibility as laid down in the e-brochure and who figure in the Provisional Merit List prepared on the basis of registration of candidates. Such candidates shall be required to produce such other additional documents as mentioned in the e-brochure or as may be further decided by the Board to ensure that only genuine and eligible candidates are considered against such seats.

## 29. CONVERSION OF CATEGORY SEATS IF ANY/FINAL ROUND BY PERSONAL COUNSELLING (MOPPING UP ROUND):

If otherwise required, the **Board** will issue Notification of final round by Personal Counseling on its website <a href="www.jkbopee.gov.in">www.jkbopee.gov.in</a> indicating schedule of selection process for final round for allotment of seats remaining vacant after completion of earlier round(s) of allotment of seats by way of Preference Forms. This final round of allotment of seats shall be conducted by way of personal counseling instead of allotment on the basis of Preference Forms to ensure that all the vacant seats are filled in before the last date fixed by MCI from time to time and there will be instant seat allocation. All the candidates who have qualified the NEET PG 2024 but could not be allocated seats in earlier rounds and have submitted the documents in BOPEE office will be eligible to appear in the final round of counseling. Those who had not submitted the documents shall, in no case, be considered, notwithstanding their merit position. The unfilled category seats shall also be filled up during the final round and by adding the same to the seats available.

On account of allotment of seats in this final round of admission, no fresh vacancies consequent upon allotments made in this round will be created. This is principally because this final round of allotment is meant to fill up (as far as possible all) available vacant seats without creating a new or fresh vacant seat on account of such allotment. During this round also, eligible candidates will appear personally (**Proxy will not be permitted**), seeking allotment of seats of their choice. Personal counseling for such allotment will be held strictly in order of earlier Merit List number of NEET-PG, 2024. Each candidate will be offered all seats that have remained vacant and are available for allotment as per merit and preference only at time of his/her turn of counseling i.e. as per Merit Position. The available seats shall be offered to the next candidate in merit.

Before personal counseling round, all available vacant seats (due to non- allotment / non-joining / resigning/ unfilled category seats to be converted to OM) will be notified on website. Eligible candidates interested to participate in this round should carefully go through vacant seats as notified on website and decide whether to participate in the Final Personal Counseling round. Such candidates, in their own interest are advised however, to be available in the BOPEE office during the mopping up round to stake a claim on the availableseats.

For the purpose of this Personal Counselling round, following seats shall be considered as available for admission which will be displayed on website before commencement of Personal Counseling round:-

- a) All seats that have remained vacant, if any, at the end of previous admission round(s) on account of non-allotment:
- b) All seats that were allotted in previous round(s) but were rendered vacant on account of candidate to whom such seats were allotted but did not join or resigned;
- c) All unfilled category seats to be converted into OM;

d) All such seats that may become additionally available on any account whatsoever, including but not limited to seats if any additionally recognized by Medical Council of India made additionally available on account of any Order that may be passed by Courts etc.

In aforesaid final round of admission by personal counseling, preference forms submitted by all eligible candidates will not be considered and same shall be treated to have been cancelled. In other words, this final personal counseling round shall not be conducted on the basis of choices given in preference forms submitted by candidates, but on the basis of the merit-cumpreference of such candidates who are available at that time/date.

All candidates to whom seats will be allotted in accordance with choice and available seats at his/her merit position at time of personal counseling, will be required to join concerned college and complete all necessary formalities (by submitting all original documents and paying prescribed fees) for taking admission accordingly within prescribed time.

Allotment of seat once made in this personal counseling round shall not be changed. At the time of this personal counseling round, candidates must consider available seats thoroughly and opt for a seat which they must join once allotted.

It is hereby made clear that in case such a candidate does not join concerned College and/or fails to comply with necessary formalities, his/her admission shall be cancelled.

Note: 1)The process of allotment of streams/institutions for MD/MS/PG Diploma & Courses by counseling shall have to be completed by the last date fixed by NMC/MCI from time to time. However, the selected candidates, who have completed their admission formalities but are no more interested in continuing their admission must resign by or before the last fixed by NMC/MCI or as decided by the Board failing which they shall not be eligible to participate in the counseling process for admission to MD/MS and other PG Diploma Course next year/subsequent years as already stated hereinabove. This is to ensure that no seat remains vacant and Board gets time to notify the unfilled and vacant seats. The candidates selected after the last fixed by NMC/MCI cannot resign so as such candidates should weigh all pros and cons before participating in the counseling.

Note:2) As decided ,the Board shall forward the list of students in order of merit equaling to ten times the number of vacant seats to the Medical Colleges by the last fixed by NMC/MCI resp. The last date of joining the college/institution shall be as notified by the NMC/MCI from time to time. The Merit List in respect of unfilled seats in if any, shall be forwarded to the college as per the date/schedule notified by .

#### **30.ADMISSION TO PRIVATE COLLEGES:**

In accordance with the amendments carried in Post Graduate Medical Education Regulations and Under Graduate Medical Regulations, 1997 carried out vide amendment Notification dated 10-03-2017 as indicated by the Ministry of Health and Family Welfare, Government of India vide their F.No.11011/1/2015-MEP(Pt.) dated 10-03-2017 it is mandatory to have common counseling for admission to UG and PG Courses in all Medical Education Institutions

in a UT of J&K by the UT Government of J&K. There shall be no exemption from common counseling and all institutions including private medical colleges/deemed universities shall be covered under it. The counseling for private medical colleges in the UT of J&K during 2019 for all the seats, including the management quota seats including those under NRI quota was done through common counseling. The seats during 2024 in the private medical College including those under management quota including NRI shall also be filled up by the BOPEE. The seats under management quota and NRI in ASCOMS have accordingly been reflected in the seat matrix.

The seats in the ASCOMS(other than under Hindu Minority and NRI Quota)shall, therefore, be filled up during the common counseling and the candidate shall be required to indicate their preferences while filling in online preference form or participate in physical round of counseling as the case may be. The candidates while indicating the preference are, therefore, advised to carefully make a choice for the seats available in the private colleges.

The seats under NRI quota and Hindu minority quota shall be filled up by the Board separately on the dates as may be notified by it in view of need for scrutiny of additional documents. The candidates claiming the seat under Hindu minority quota shall necessarily have to obtain a certificate to the effect of belonging to Hindu minority from the competent revenue authority. However, only such candidates shall be allowed to compete against the NRI/HMQ seats who have registered themselves and figure in the PML.

The seats under NRI/HMQ category shall be filled up from amongst the candidates belonging to the UTs of Jammu and Kashmir/Ladakh and shall be filled in accordance with the following criteria:-

- Only such candidates shall be considered under management/NRI/Hindu minority quota who are resident of the Jammu and Kashmir or Ladakh;
- ❖ Who have applied under NEET 2024and have qualified;
- ❖ Have been found eligible to participate/compete against these UT of J&K
- ❖ Have registered online for being included in PML and submitted such other documents as may be required by the Board for determining the eligibility.

The eligibility criteria for competing under NRI quota seats shall be as under:-

- ➤ Where applicant himself/herself is NRI and family originally belongs to J&K (Category 1);
- ➤ Children of NRI who originally belong to UT of Jammu and Kashmir or Ladakh (Category 2);
- Any other condition as notified by the Government of India/UT Government to be eligible to compete for such seats or the law laid down by the Hon'ble Supreme Court on the subject.

#### **Documents required for NRI Category 1 and Category 2 candidates:**

#### Category No. 1:

- a. NEET PG Score Card- 2024;
- b. NRI certificate issued by the Ministry of External Affairs, Govt of India or Indian Embassy Overseas under Ministry of External Affairs with holding of Indian Passport;
- c. NRI Bank Account preferably in the country where the candidate is residing or of NRI Account in India:
- d. Copy of Indian Passport;
- e. Copy of Income Tax Return filed in India, if any;
- f. PAN Card No., if any and
- g. Domicile Certificate of the candidate belonging to UT of J&K or Ladakh as the case may be;
- h. Any other document as may be required by the Board to its satisfaction.

# Category No. 2:

- a. NEET PG Score Card- 2024;
- b. NRI Sponsorship letter;
- c. Undertaking of NRI duly attested by the legal authority of that country where sponsor is residing or Indian Embassy Overseas;
- d. Bank statement of the sponsor;
- e. Resident/National certificate or NRI certificate of the sponsor;
- f. Pedigree table/family tree establishing relationship of the candidate with the sponsor along with documentary proof;
- g. Employment certificate of the sponsor;
- h. PAN Card No., if any of the sponsor;
- i. PAN Card No., of the candidate/parents;
- j. Copy of the Income Tax Return filed, if any and
- k. Domicile Certificate of the candidate belonging to UT of J&K or Ladakh as the case may be. In case of non-availability of candidates under NRI quota, the seat shall be allotted to such candidates on merit cum preference as may be notified by the Board.

Annual fee for the management quota seats can be confirmed from the respective college only. The candidates competing for such seats are, therefore, advised to confirm the same from the official website of the concerned Medical College (ASCOMS) or contact personally for fee and other formalities for admission procedure to MD/MS /PGD Courses.

In case NRI seat is allotted to a non NRI candidate in view of non-availability of candidates, annual fee for such seat shall be as may be notified by the Board in due course of time but before filling up of seats and preferably before the start of counseling. The eligibility of candidates shall, however, be the same as applicable to other candidates competing for OM seats in the Government Medical Colleges as notified hitherto fore.

Note:- The admission in private medical colleges shall be held simultaneously against the OM (other than those Hindu Minority/NRI) seats along with the other seats being filled up for Government Medical Colleges on the basis of the merit and the preferences indicated by the candidates. The candidates are advised to carefully make a choice for the seats available in private colleges. However, seats under Hindu Minority Quota and the NRI Quota shall be filled up by the Board through physical counseling as per schedule as may be notified by the Board.

# **31.FEE STRUCTURE (TENTATIVE):**

Fee for government/private colleges is shown below:-

The above fee is purely tentative and is subject to changes as may have been notified by the colleges in accordance with standing rules. The candidates competing for such seats are, therefore, advised to confirm the same from the official website of the concerned Medical Colleges or contact personally for fee and other formalities for admission procedure to /MD/MS /PGD Courses.

#### 32.PROHIBITION AND GUIDELINES

The candidates who were selected for these courses must ensure that:

The guidelines to curb the menace of ragging in professional colleges issued by the Hon'ble Supreme Court of India are as under:-

An annual undertaking signed by each student, whether fresher or senior and his/her parent(s) jointly stating that each of them have read the relevant instructions/regulations against ragging, as well as punishments, and that if the ward has been found guilty he/she shall be proceeded against, shall be prosecuted.

Such an undertaking shall be furnished in English as well as vernacular (mother tongue of the parent) at the beginning of each academic year by every student.

An undertaking to the similar effect should be obtained every year from each student admitted to the hostel.

The compliance to the above effect shall be ensured by each of the affiliating university to which the concerned institution is affiliated and would be verified by them annually.

In order to ensure "the ragging free environment" in the campus, each institution shall compulsorily in the prospectus and other admission related documents, depict the earlier directions of the Apex Court and/or of the Central or State Governments as applicable, so that candidates and their parents are sensitised for the same.

#### **33.RAGGING IS BANNED:**

The Candidates admitted must be aware of the fact that:

ragging is totally banned/ prohibited in Medical College/ Institutions and any one found guilty of ragging and / or abetting it, is liable to be punished. Accordingly, candidates have to sign an undertaking at the time of counselling that they will not resort to ragging. Selected candidates have to follow strictly Medical Council of India (Prevention and Prohibition of Ragging in Medical Colleges/Institutions) Regulations, 2009 and or instructions on subject.


# Ragging includes following:-


Any conduct where by words spoken or written or by an act which has effect of harassing, teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking students to do any act or perform something which such student will not do in ordinary course and which has effect of causing or generating a sense of shame or embarrassment so as to adversely affect physique or psyche of a fresher or a junior student.

#### **34.PUNISHABLE INGREDIENTS OF RAGGING:**

- ➤ Abetment to ragging;
- Criminal conspiracy to rag;
- Unlawful assembly and rioting while ragging;
- Public nuisance created during ragging;
- Violation of decency and morals through ragging;

(1) 2<sup>ud</sup> proviso to sub clause (v) of clause 3 shall be substituted by the following:-

"provided further that the doctors who are doing post-graduation/diploma courses in any specialty at the Government expenses including those who leave the course midway after cut of date of admission shall not be eligible to apply for undergoing post-graduation courses in any other specialty in the State Medical Institutions till completion of their Post-Graduation/Diploma Courses, as the case may be. In case of candidates having left the course midway after taking admission they shall be barred from seeking admission again until they would have normally completed the course had they not left it midway."

- (2) Clause 4-A shall be substituted by the following:-
  - "4-A. Weightage of serving in difficult areas:- The candidates shall be entitled to weightage for serving in the difficult areas as defined under notification SRO 201 of 2006 dated 15.06.2006 to the extent of additional 10% for each year of completed service in such areas subject to a maximum of 30% of the marks obtained in the written test. Provided that each completed year of service shall mean actual service days even on adhoc/contractual basis or as NRHM Doctor in these areas to be certified by the concerned Director Health Services and shall exclude the days spent on any training programme or absence of any kind except such absence on easual leave"

WHEREAS MBBS seats from Central Pool (herein after referred to as Central Pool Ladakh Merit Seats) are being allotted every year to Union Territory of Ladakh by the Ministry of Health & Family Welfare, Government of India. In addition, certain seats have been allotted by the Government of Jammu and Kashmir to Union Territory of Ladakh (herein after referred to as J&K Pool Ladakh Merit Seats) for MBBS/PG Degree in clinical, para-clinical, and non-clinical courses/DNB/PG Diploma in clinical and non-clinical courses, specifically with a view to meeting shortage of doctors etc. in Ladakh and hence not based on All India/J&K Merit but on Ladakh specific Merit list in NEET/J&K medical entrance examinations;

WHEREAS there is a scarcity of doctors in Union Territory of Ladakh and consequently there is an urgent need to take certain measures to ensure availability of doctors to provide quality healthcare to people in Union Territory of Ladakh;

WHEREAS with the objective of overcoming scarcity of doctors in Union Territory of Ladakh, the Administration of Union Territory of Ladakh had formulated the Compulsory Government Service Policy for those who avail Central Pool Ladakh Merit Seats or J&K State Pool Ladakh Merit Seats vide Notification No.M-17030/7/2021 dated 23-08-2021;

AND WHEREAS the Administration of Union Territory of Ladakh has decided to revise the aforesaid Compulsory Government Service Policy.

NOW, THEREFORE, the Administration of Union Territory of Ladakh revises the Compulsory Government Service Policy as follows, to be applicable from Academic Session, 2022onwards:

 For the purpose of this Compulsory Government Service Policy, unless the context otherwise requires 'Candidate' means the student who intends to pursue medical course under Central Pool Ladakh Merit Seat or J&K State Pool Ladakh Merit Seat.

(2) Every candidate who intends to avail a Central Pool Ladakh Merit Seat or J&K State Pool Ladakh Merit Seat, as the case may be, shall execute a Compulsory Service Bond (hereinafter referred to as the Bond) in favor of the Administration of Union territory of Ladakh and submit it in original to Director Health Services, Union territory of Ladakh, inter-alia, stating that:

- a) he/she shall serve under the Administration of Union territory of Ladakh for a compulsory period of 05 (five years) immediately after successful completion of MBBS Course. If he/she fails to serve the aforesaid stipulated period, he/she shall have to pay an amount of Rs. 50,00000/ (Rupees fifty lakhs only) to the Administration of the Union Territory of Ladakh.
- b) he/she shall serve under the Administration of Union territory of Ladakh for a compulsory period of 03 (three) years immediately after successful completion of PG Degree in Clinical Courses. If he/she fails to serve the aforesaid stipulated period of 03 (three) years, he/she shall be required to pay an amount of Rs. 50,00000/- (Rupees Fifty Lakhs Only) to Administration of Union Territory of Ladakh.
- c) he/she shall serve under the Administration of Union territory of Ladakh for a compulsory period of 02 (two) years immediately after successful completion of Medical Course not covered under clause (a) and (b) above. If he/she fails to serve for the aforesaid stipulated period, he/she shall be required to pay an amount of Rs. 45,00000/ (Rupees Forty-Five Lakhs Only) to the Administration of Union Territory of Ladakh.
- (3) Before allocating a Central Pool Ladakh Merit Seat or J&K State Pool Ladakh Merit Seat, Director, Health Services, Union Territory of Ladakh or J&K Board of Professional Entrance Examination (BOPEE), as the case may be, shall obtain the Bond in original from the candidate who intends to avail such a seat.
- (4) The candidate allotted a Central Pool Ladakh Merit Seat or J&K State Pool Ladakh Merit Seat, shall communicate, in writing, to the Director, Health Services, Union Territory of Ladakh, within 10 days of his/her successful completion of the course. The obligation to serve compulsory period shall not be applicable if his/her appointment under the Administration of Union territory of Ladakh is not made by the Administration of Union Territory of Ladakh with in a period of two months from the date of the aforesaid communication by the Administration.
- (5) A candidate, who is serving compulsory period shall be permitted to undergo PG Degree course or PG Diploma course, but he/she shall be required to serve the remaining bond period after successful completion of PG Degree course or PG Diploma course, as the case may be, such that he/she serves a total compulsory period of five years. For undergoing the afore said PG Degree/Diploma course, he/she shall be required to submit proof of his/her selection to the PG course, along with a request letter seeking permission to undergo the said course, to Director, Health Services, Union Territory of Ladakh. He/she shall also be required to furnish a certificate, duly signed by the Principal/Head of the Institute/College, by 31st January and 31st July every year stating that he/she is undergoing the said course in the Institute/College.
