- b) The candidates should report their original certificates and Demand Draft or UTR Number for Electronic Fund Transfer through NEFT / RTGS for prescribed tuition fee & other fees as specified herein below.
- c) i) Candidates without original certificates / documents shall **not** be allowed to take admission in the allotted Medical College.
- ii) Candidates who have deposited their original documents with any other Institute / College / University and come for admission with a certificate stating that “their original certificates are deposited with Institute / College / University” shall **not** be allowed to take admission in the allotted Medical College.

- a) Candidates are instructed to visit the **MCC of DGHS** (Directorate General of Health Services), Ministry of Health & Family Welfare, Govt. of India, New Delhi **website: www.mcc.nic.in** and **College website: www.vmkvmc.edu.in** from time to time.
- b) **Provisional Allotment letter given by the MCC of DGHS for admission is subject to fulfillment of all the eligibility criteria prescribed by the NMC and medical fitness of the candidates.** Those who do not fulfill the prescribed eligibility criteria and medical fitness will not be admitted to the course of study to which they are allotted by **the MCC of DGHS**. If it is found at a later stage that the candidate has given false information / forged certificates or concealed material information, his / her admission will be cancelled without any notice.

- c) Students will be governed by all the University rules including refund of fees, hostel rules, disciplinary rules and UGC / NMC Regulations for Curbing the Menace of Ragging etc.
