Online Mop-up round seat allotment – UG Medical 2024 (Mop-up round schedule for Dental and AYUSH courses will be published later)

The list of un-allotted medical seats after second round seat allotment and the seats cancelled after second round is displayed on the KEA Website for the information of the candidates. These seats will be offered in the Mop-up Round to the candidates who have qualified in UGNEET-2024 but who have not been allotted medical seat. Candidates who have allotted seat and cancelled by forfeiting the Caution Deposit can also participate in the Mop-Up round.

Interested candidates can participate in the Mop-Up Round for the available Medical seats. The seats identified as vacancies after second round would also be added.

## MEDICAL COURSE FEE DEPOSIT

- a. Candidates who are willing to participate in the UGNEET 2024 Mop-up round should pay **MEDICAL COURSE FEE DEPOSIT** as detailed below.
- b. Candidates who have paid the Caution Deposit for the second round and did not get any medical seat should pay the MEDICAL COURSE FEE DEPOSIT after deducting the caution deposit amount.
- c. If a candidate gets the medical seat, the **MEDICAL COURSE FEE DEPOSIT** will be adjusted towards the fee.
- d. If a candidate gets the medical seat in the mop-up round and fails to report to the college, or fails to take admission in the allotted college or likes to cancel the medical seat, MEDICAL COURSE FEE DEPOSIT will be forfeited. (Candidate has to pay the penalty amount as per rules and the candidate will not be eligible to participate in the counselling including AIQ in the coming years)
- e. The fee paid at KEA for other courses will not be considered as **MEDICAL COURSE FEE DEPOSIT**.

## MEDICAL COURSE FEE DEPOSIT DETAILS

Candidate has to pay the MEDICAL COURSE FEE DEPOSIT by downloading the Challan or through online mode from 05-10-2024 to 08-10-2024. Candidates who have paid the Caution Deposit for the second round and did not get any medical seat should pay the MEDICAL COURSE FEE DEPOSIT after deducting the caution deposit amount.

'N' / 'Q' Seats	Rs. 25,00,000/-	Allowed to enter all type of seat options (Candidate has to pay the balance fee after announcement of results)

### **ELIGIBILITY TO PARTICIPATE IN THE MOP-UP ROUND**

Candidates who have NOT been allotted any Medical seat in KEA either in First Round or in the Second Round of UGNEET 2024 or after allotment of Medical seat surrendered the medical seat by forfeiting the Caution Deposit are only eligible to participate in Mop-Up round for the available Medical seats. Candidates who have been allotted Dental seat through KEA can participate for Medical seat but not for dental seat again, like wise candidates who have been allotted AYUSH seat can participate for medical seat but not for AYUSH seat.

### PLEASE READ THE FOLLOWING INSTRUCTIONS

- Candidates who have been allotted Medical seat in KEA either in First Round (Choice 1 & 2) of UGNEET-2024 or in the Second Round of UGNEET 2024 are not eligible to participate in the medical mop-up round.
- 2. Choice-3 candidates of first round and allotted Medical seat in the second round and paid the fees are not eligible for mop-up round of UGNEET-2024.
- Candidates who have reported to the college after allotment of seats in the first round or second round AIQ and / or allotted a seat in mop-up round of All India Counselling including Counselling for Deemed Universities / Central Universities are not eligible for UGNEET 2024mop-up round being conducted by KEA.
- 4. Candidates are advised to visit KEA Website for seats availability / vacant seats for mop-up round allotment before participating as well as to know about the fee structure in different colleges / category of seats.
- 5. Candidates are also advised after knowing /confirming the fee structure, and after discussion with parents participate in this mop-up round.
- 6. Candidates who are already admitted to AYUSH and DENTAL colleges are advised to attend this round only if they are interested and after confirming of getting the original documents within the stipulated time from the present college. The seat selected by the candidates in any discipline will get cancelled automatically upon allotment of a seat in this round and for any reason they will not get back the old seat but to compulsorily join the allotted colleges.
- 7. The responsibility of obtaining the original documents from the present college for admitting to the newly allotted college within the stipulated date and time solely lies with the candidates.
- 8. Candidates have to compulsory report to the allotted college on or before the last date prescribed and if a candidate fails to report to the allotted college they will not be having any seat in their favour; they will lose both the seats and fee will not be refunded. After the seat allotment in this round candidate has to compulsorily report to the allotted college.

OPTION ENTRY (From 2.00 pm on 07-10-2024 to 14-10-2024 – 11.00 am – only to the candidates who pays the MEDICAL COURSE FEE DEPOSIT – Candidates have to enter the options after payment of MEDICAL COURSE FEE DEPOSIT)

- a. The eligible candidates who pay the **MEDICAL COURSE FEE DEPOSIT** will be allowed to enter the options.
- All the eligible candidates have to enter the new options for this medical mop-up round. The
  options entered by them in the previous rounds will not be considered.
   Date of publication of Provisional seat allotment results of mop-up round will be informed later.
